Help Fort Collins Be Flood Ready

- Know the Flood Risk Visit fcgov.com/floodplainmaps and search by address, parcel number or street intersection to see the floodplain map, which includes FEMA- and City-designated floodplains.
 - City-Designated Floodplains In addition to the floodplains shown on a FEMA map, Fort Collins Utilities has adopted floodplains in other parts of the city. It is important for potential buyers to be aware of all floodplain designations, even though there is not a mandatory flood insurance purchase requirement.
- Additional map information Utilities can provide details about floodplain mapping, including flood elevations, floodway designations, Flood Insurance Rate Maps, erosion buffer zones and past flood history. Call 970-221-6700 for details.
- Elevation certificates available Elevation certificates are available for some properties. Call 970-221-6700 to check for availability.
- 2. Everyone can Purchase Flood Insurance Flood insurance is an important consideration. Remember: (1) Only flood insurance covers floods; (2) You don't have to be in a floodplain to get flooded; and (3) Everyone in Fort Collins can purchase flood insurance even renters. Because Utilities' Stormwater program ranks in the top 1 percent of programs nationwide, customers can qualify to receive up to a 30 percent discount on flood insurance. 3. Build Responsibly: Know the Floodplain Regulations — Before any construction (new development, addition, remodel, filling, grading, etc.) takes place on a property, contact Fort Collins Utilities for specific floodplain regulation requirements. It is better to understand the regulations prior to developing specific building plans.


Highlights:
